Notification of changes to the Underlying fund of R200 Fidelity US Dollar Cash Fund (the "Affected ILP sub-fund")

We are writing to you as your policy holds units in the Friends Provident International Limited investment-linked policy ("ILP") sub-fund named above. We have been notified by Fidelity International (the "Company") of the following changes which impact the Fidelity Funds – US Dollar Cash Fund (the "Underlying fund"), which is the underlying fund of the Affected ILP sub-fund.

Re-classification from Article 6 to Article 8

The Company has conducted a thorough analysis of the investment policy and investment process of the Underlying fund, and has decided that with effect from **16 August 2022** (the "Effective Date"), the Company will re-classify the Underlying fund to Article 8 ("Re-classification") under Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector ("SFDR"), in accordance with Fidelity's Sustainable Investing Framework (as detailed in the Underlying fund's Prospectus).

Implication of the changes

Following the Re-classification, the Underlying fund's English name will be amended to include the word 'Sustainable', and the investment objective will be enhanced with further sustainability-related disclosures regarding the promotion of environmental and social characteristics pursuant to Article 8 of the SFDR. However, the enhanced disclosures do not represent a material change to the investment strategy or investment policy of the Underlying fund.

Additionally, there will be no change in the fee level or costs of the repurposed Underlying fund, following the implementation of the changes detailed in this notice. The costs and/or expenses incurred in connection with the changes detailed in this notice will be borne by FIL Fund Management Limited, the Investment Manager (and/or any of its affiliates within FIL Group) of the Underlying fund of the Affected ILP sub-fund.
